

## **Back Country Permits Saw Highest One Day Volume Ever**

The Forest Service requires anyone who leaves the boundary of the Arizona Snow Bowl, whether they are skiers or hikers, to have a permit. Permits are issued at the offices of the CNF and by FoNAF volunteers on weekend mornings at the Agassiz Lodge.

Back in the fall, we anticipated a record year of permit activity based on the forecast of a huge El Nino system. While the actual snowpack was not a record, it was still sufficient in the 2015-16 season to generate a very large number of permits to be issued – second only to the 2009-10 season. Some 14 FoNAF volunteers issued 368 permits between December 5<sup>th</sup> and the end of February. On January 9<sup>th</sup>, Bill Waters and Bruce Belman wrote 50 permits between 9 and 11:30! Note to scheduler: we need to have more than two volunteers on the busy weekends at the beginning of the ski season.

## **Aspen Team Has a Full Calendar Planned for 2016**

Once the Forest Service opens their roads that have been closed for the winter, twenty FoNAF members will be visiting the aspen exclosures for which they are stewards to determine if they have been damaged by the snow pack or winds. They are asked to report any needed repairs to me and I will coordinate visits by the fence team to make them as soon as possible to prevent the exclosure from being visited by any ungulates wanting to snack on young aspen. Our hope is always that the damage is minimal and the number of days needed for repairs is low so we can quickly move on to some major projects, but we had several very windy days in March so we may not be too lucky.

Our list of large projects is long and growing. We plan to build at least three -- and possibly as many as six -- new exclosures on the Flagstaff Ranger District (FRD). Two will be along US180 at what used to be called aspen corner but is now mostly downed trees. The third is further north but also along US180. Using funds from the Kenny Lawrence Fund that were donated to FoNAF and a matching grant from the National Forest Foundation, we will plant almost 1000 aspen saplings in these three exclosures so that future generations of residents and visitors will have large tracts of aspen right along the highway to enjoy. Time and materials availability permitting, we will build some additional aspen fences at locations yet to be determined.



We have been asked to assist in the construction of a new exclosure at Buck Spring on the Mogollon Rim District (MRD) that will provide protection of a small tract of aspen and a new exclosure along FR321C to protect a riparian area populated with Bebb willows. We plan to continue visiting the MRD to survey and document the condition of a large number of exclosures for which no current documentation exists. And finally we have agreed to assist in rebuilding many miles of pasture and right-of-way fences to insure that they are pronghorn friendly, i.e., the bottom strand of wire is smooth (not barbed) and 18” above ground.

## **Aspen Team Endures Snow for Early Fence Repairs**

On April 29<sup>th</sup> a small group of Aspen Team members made repairs to several enclosure fences that had been damaged from snow and wind. Over the winter months trees fall on the fences due to wind or heavy snow fall causing gaps in the fences or downing complete sections. When the fences are damaged the aspen saplings inside the enclosures are "browsed" by elk and deer (yum).

The earlier the repairs are made in the spring significantly improves the chances for protecting the young saplings. So the team of five members including Dave Downes, Tom Mackin, Bill Kluwin, Jim Hoyne, and Bob Dyer went out to repair six sections of fence on four different enclosures. The weather was initially difficult

with snow and wind (see photo), but turned intermittent during the day allowing for successful repairs to all targeted fences.



Besides the planned new enclosures for 2016 that the Aspen Team will build, there will be ongoing repairs to damaged fences. Unfortunately the damage is often not due to weather but also caused by human intervention. The team is perplexed when a good fence is seemingly ruined by hunters or curious people that apparently have an overwhelming desire to see what's inside an enclosure.

The Aspen Team events calendar has many days during 2016 designated for fence repairs, so please check their events calendar for future outings when the weather will be much more enjoyable than on April 29<sup>th</sup>.
